### INVESTMENT PHILOSOPHY

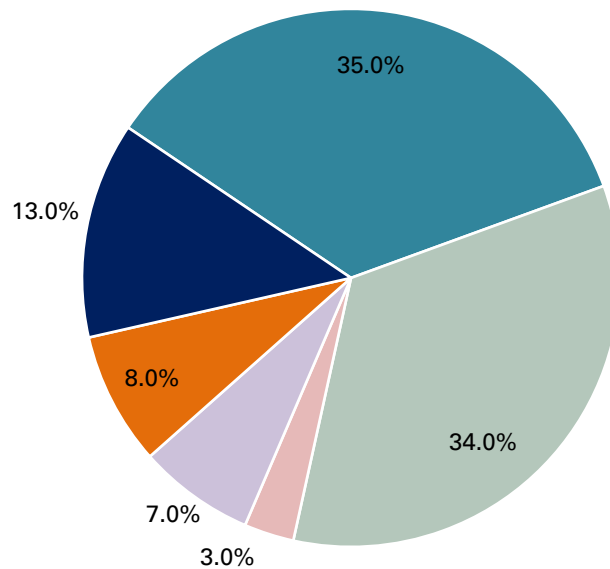

The interest rate and market value of the model will change in reaction to interest rates, government policies and worldwide economic conditions. The Aggressive Model is exclusively a stock portfolio, utilizing mutual funds that could include both domestic and international securities. The portfolio is diversified between value and growth, large and small, and domestic and international companies.
